## Members Present: 87

The reading of the minutes of our Semi-Annual meeting was waved by unanimous consent.

<u>Introduction</u>: Elayne introduced and thanked the current Board Members. She then thanked the tournament managers and team members, the rules committee, and the Monday and Wednesday cash game helpers for their work and dedication to the club.

<u>Election of Officers for 2015</u>: There was a unanimous vote to accept the slate of candidates who ran unopposed: President Elayne McCracken, Vice President Bob McCracken, Secretary Haydee LaBreche, and Treasurer Sandy Sirull will all serve another term. The members present voted by secret ballot for two new Members-at-Large. <u>Changes to our By-Laws</u>: These changes, which were previously emailed to all the members, were accepted by unanimous vote.

<u>New Business</u>: On Tuesday, December 2, we will start an experimental game in the rear of the room. It will be a deep stack with 12,500 chips, a buy-in of \$30, a starting time of 3:30 p.m., and have a 20 minute dinner break.

As no other business came before the floor, meeting was adjourned at 4:25 p.m.
