Lane Roehl: Lane submitted a revised, combined Tournament Attendance/Payout sheet for review. The new sheets will be used once the supply of current sheets is depleted. There is now a binder of weekly results which will be located, and should remain, on one of the back tables. He also reported

that the Free Hold 'Em lessons has new participants every week and has generated several new club members.

Website usage was shared. There were 450 hits to the website in 2024. It was decided there is value to having a club website for new members looking at joining the club.
